By submitting this form, I agree to adhere to the following terms and conditions

1. I shall not use archival resources for commercial purposes and will use them solely for the purposes declared in **Section I**. Any use of the archival resources beyond those specified in **Section I**, I shall require prior written authorization from the BOT.

2. I shall not view, cite, or reproduce any archival resources from the BOT without prior written authorization.

3. I shall reproduce archival resources solely for the purposes specified in Section I, and refrain from any commercial purposes.

4. If you are citing an item from the BOT, I shall acknowledge the BOT as the source of the resources.

5. I shall submit to the BOT two copies of the publication or work product in which the reproduced records are used after completion of the publication or product. These copies may be made available for public reference at BOT.

6. I shall take responsibility for any liability, damage, loss or expenses that may be incurred as a result of the use of the archival resources.

7. I acknowledge that, to ensure the long-term preservation of the archival resources, staff may refuse reproduction

requests if reproduction could potentially damage the archival resources.

8. I understand that reproduction fees will be charged according to the regulations set by The Bank of Thailand's Official Information Commission.

9. The BOT reserves the right to provide archival resource services, which must comply with the purpose(s) specified in **Section I** and are contingent upon the size of request, the nature of the document(s) and the availability of staff to ensure comprehensive service delivery.

The Bank of Thailand reserves the right to take legal action if any viewing, citing and reproducing of archival resources for publication, advertising, or dissemination occurs, either in whole or in part, or if the archival resources are used for purposes other than those specified in this request form, without prior written authorization from the BOT. Such actions will constitute a breach of these terms and conditions and may result in legal proceedings.
